Further the Vice-Chancellor apprised the members that all examinations will be regularized from the current session and it will be placed before the NAAC Team.*

### **Proceedings**

- 1) Considered the proceedings of the last meeting of the Academic Council held on the 16<sup>th</sup> April, 2015 and it will be confirmed. Some members have raised the issue of not reaching information regarding the last meeting and the Registrar has assured the members that notice will be conveyed to the members on time in future.*

- 3) The Academic Council considered the draft admission ordinance and examination regulations of Undergraduate Courses based on semester system to be introduced from the Academic Session 2015-16 and resolved that it be approved. Further, resolved that the information shall be sent to the Heads of the University Departments to frame syllabus of B.A./B.Sc./B.Com based on Semester System.*
- 4) Considered the eligibility criteria regarding fulfillment of Ph.D. work who have registered themselves from 2012 onwards under UGC Regulations, 2009 and to issue certificate in respect to fulfillment of the norms as per the prescribe guidelines laid down and resolved that it be approved. Further, resolved that a candidate, who has completed their Pre-Ph.D. Course work under the U.G.C. Regulations, 2009 may also be issued certificate.*






